The Fund is mainly exposed to the issuers of the benchmark, however, the management of the Fund is discretionary, and will be exposed to issuers not included in the benchmark. The Fund monitors risk exposure in relation to the benchmark however the extent of deviation from the benchmark is expected to be material.


